Processing of personal data

In this page are described the website management procedures with reference to the users' personal data processing which interact with web services on the OMARS S.p.A. website.

The information is supplied only for this website and not for other websites which are possibly visited by the users through the link.

Under article 13 of the Reg. EU 2016/679 (GDPR), the undersigned, as data controller, informs you that the obtained personal data will be the subject of processing operation while respecting the rights of the fundamental freedoms, as well as the dignity of the data subject, with particular reference to the privacy and personal identity and the right to the personal data protection.

Therefore, under article 13 of the mentioned Regulation, we give you the following information:

Navigation data

The computer systems and the software procedures responsible for this website functioning acquire, during their normal exercise, some personal data which the transmission is implied in the use of internet communication protocols.

It's a question of information that is not collected in order to be associated to the identified data subjects, but that for their nature could allow to identify the users through processing and associations with data held by third parties.

In this data group there are the IP addresses or domain names of computers used by website users, the addresses in URI notation (Uniform Resource Identifier) of the required resources, the time of request, the used method in order to submit the request to the server, the file dimension obtained in response, the numeric code which shows the response status given by the server (success, error, etc.) and other parameters relevant to the operating system and to the user's IT environment.

This data is used only in order to obtain anonymous statistical information on the website use and to check the proper functioning and it is promptly deleted after the processing. The data could be used for the detection of responsibility in case of IT hypothetical crimes to the website damages.

Data willingly supplied by the user

The optional, explicit and voluntary email sending to the addresses showed on this website involves the subsequent purchase of the sender's address, necessary to answer to the requests, as well as possible other personal data in the communication.

Specific summary information will be gradually put or viewed in the website pages prepared for peculiar on-demand services.

The information processing which concerns you will be based on principles of fairness, lawfulness, transparency and protection of privacy and they will be processed and retained with IT instruments and with paper methods for the time strictly necessary to achieve the aims for which it has been collected.

Specific safety measures are observed in order to prevent the data loss, improper uses or non-authorized accesses.

The possible providing data is optional, however, the rejection to supply proper personal data for the purpose of collecting it won't allow the obtaining of what is required.

The processing operations connected to this website services verify at the seat of OMARS SPA and are taken into charge by our people in charge of the processing operation and by the hosting provider.

Your personal data will not be in any case subject to dissemination if not upon specific consent.
