For the answer it will be used in the first place the same channel adopted by the data subject for the sending of the form.

The request, if legitimate and justified, is exercisable free of charge; when an amount by way of reimbursement of expenses is chargeable, the data subject will be previously warned, and it will be asked confirmation before proceeding.

The maximum emission times of the answer by the company OMARS S.p.A. are fixed in 30 days from the receipt of the filled out form.

When the form has not shown up in person to our people in charge who will proceed to a direct identification, it is necessary to attach a copy of the identification document shown in the first page of the form; the copy will be contained in the acts and retained after affixing of a cancellation wording (i.e. "this document has been acquired by OMARS SPA together with the exercise form of the data subject's rights shown on...").
